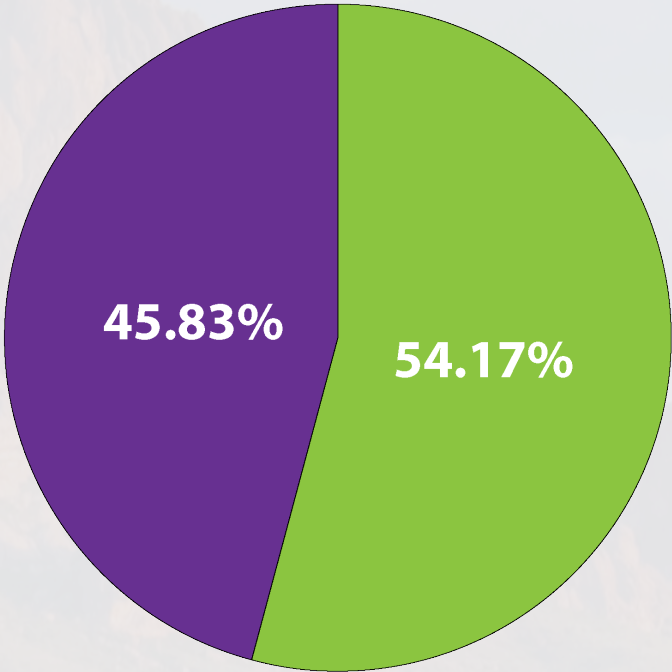

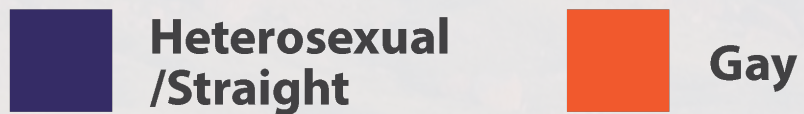

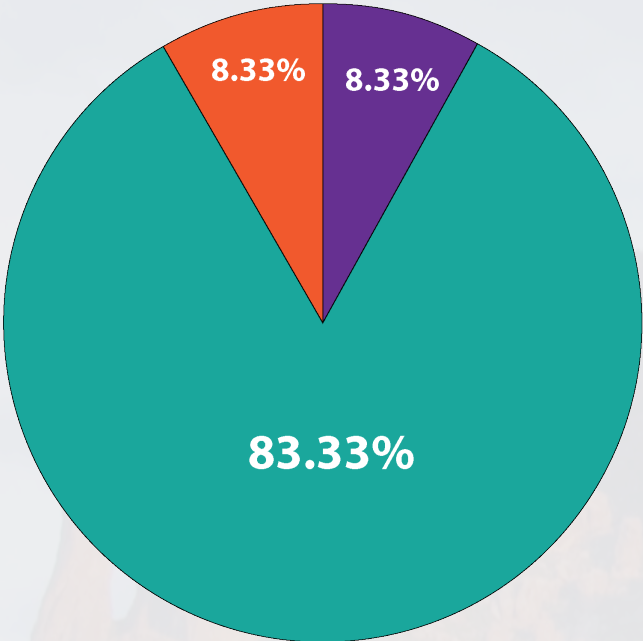

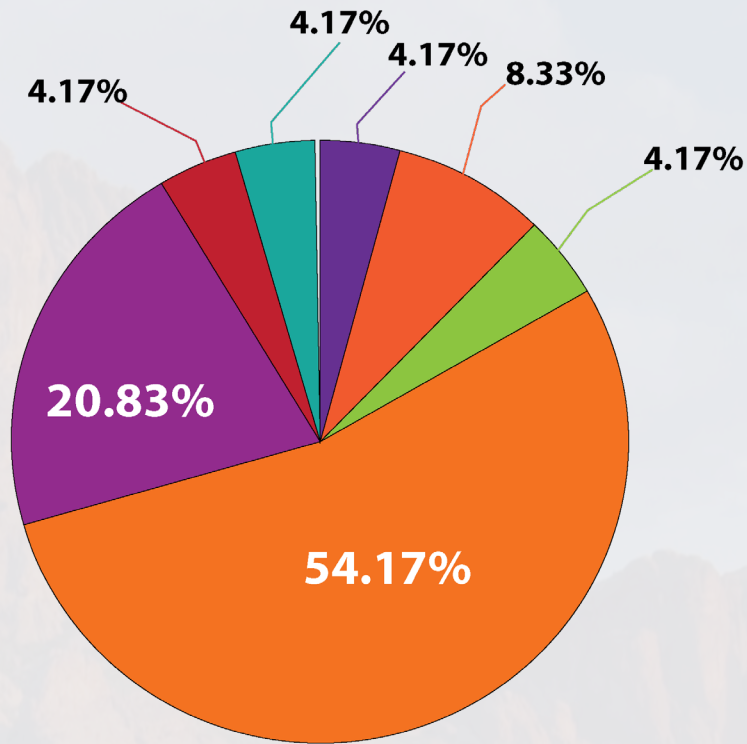

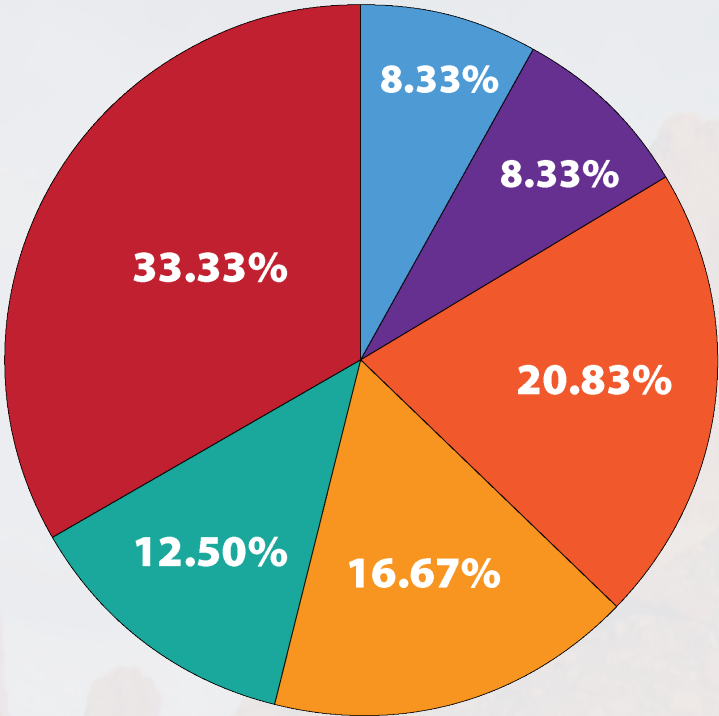

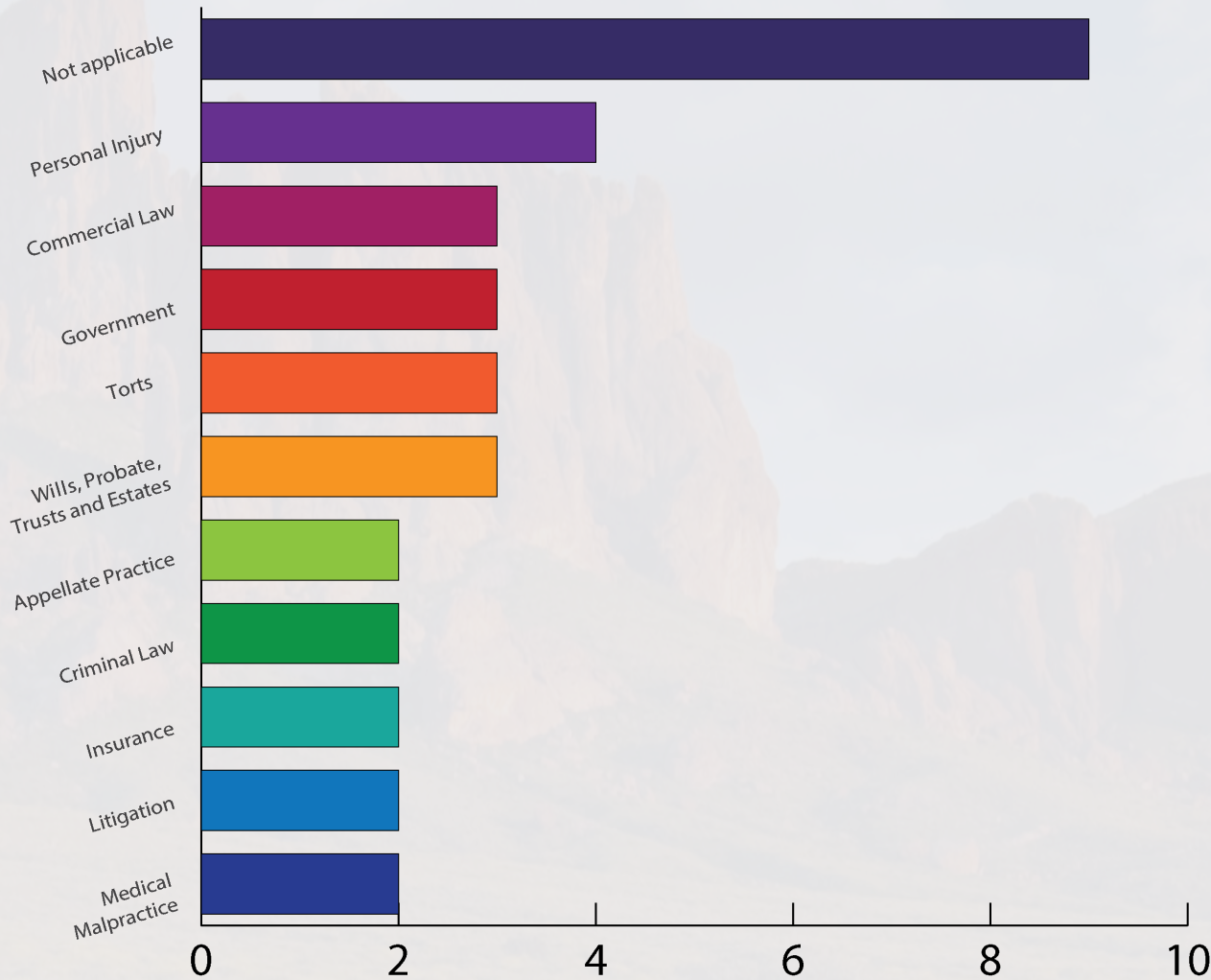

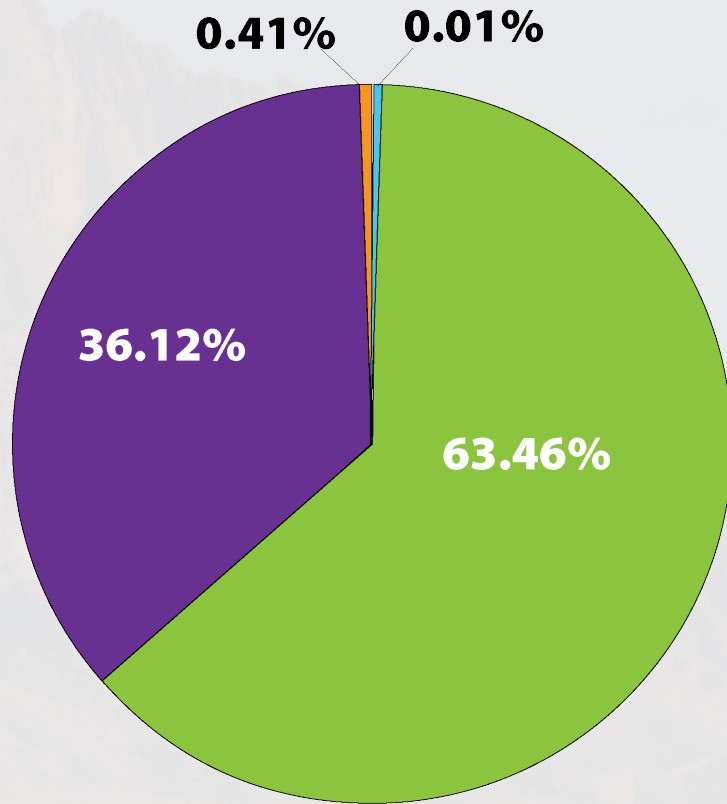

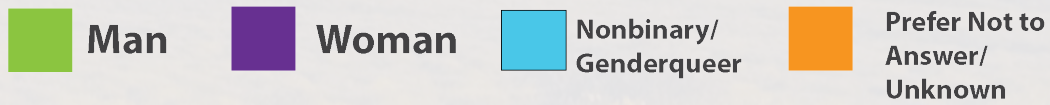

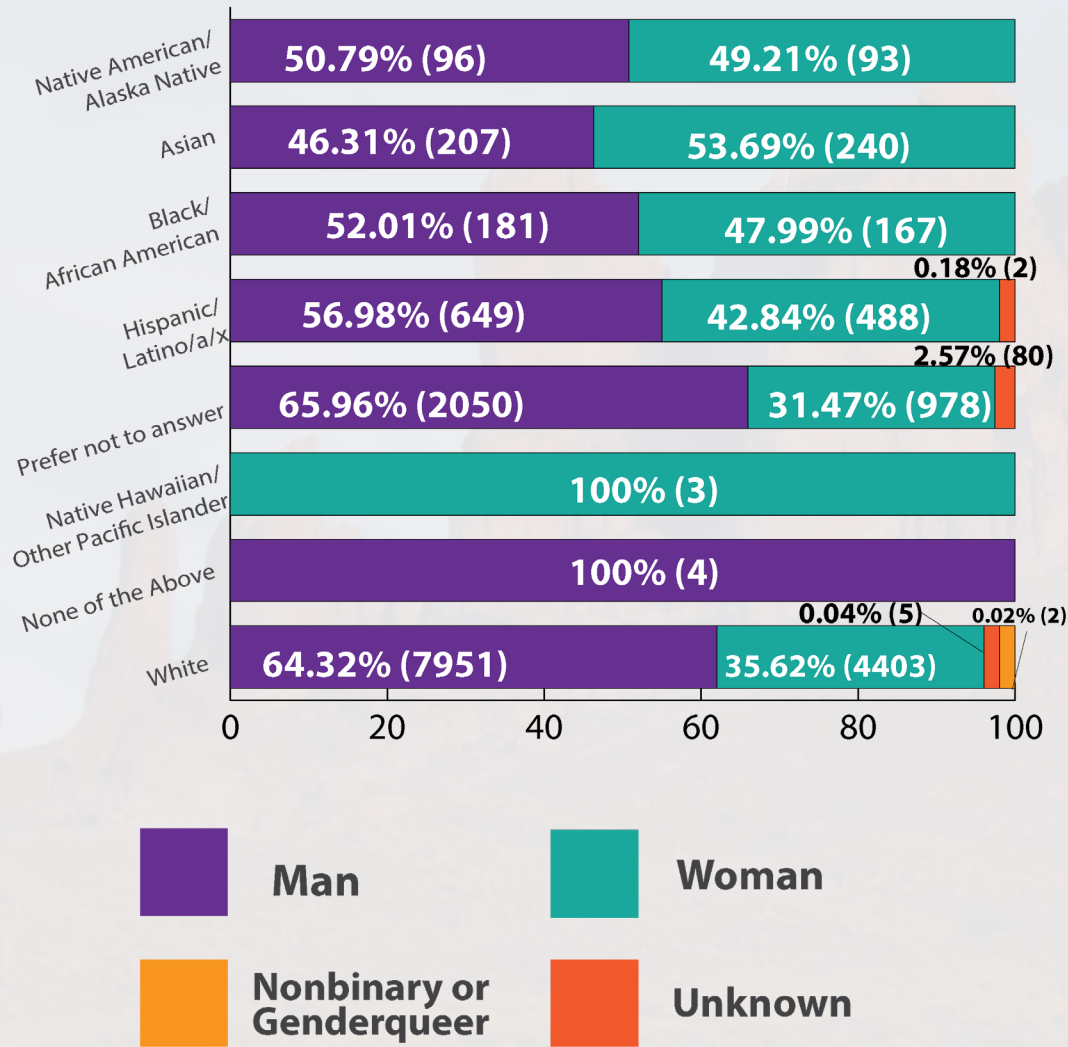

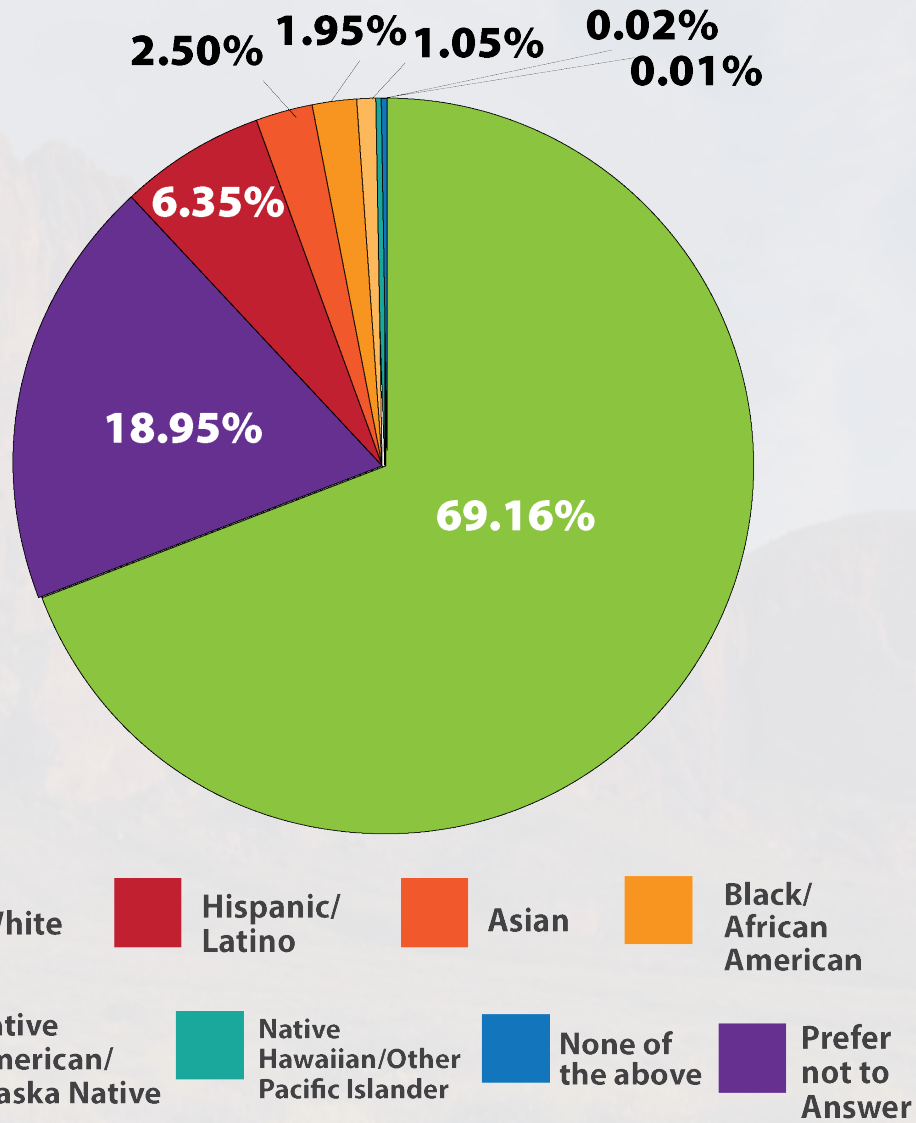

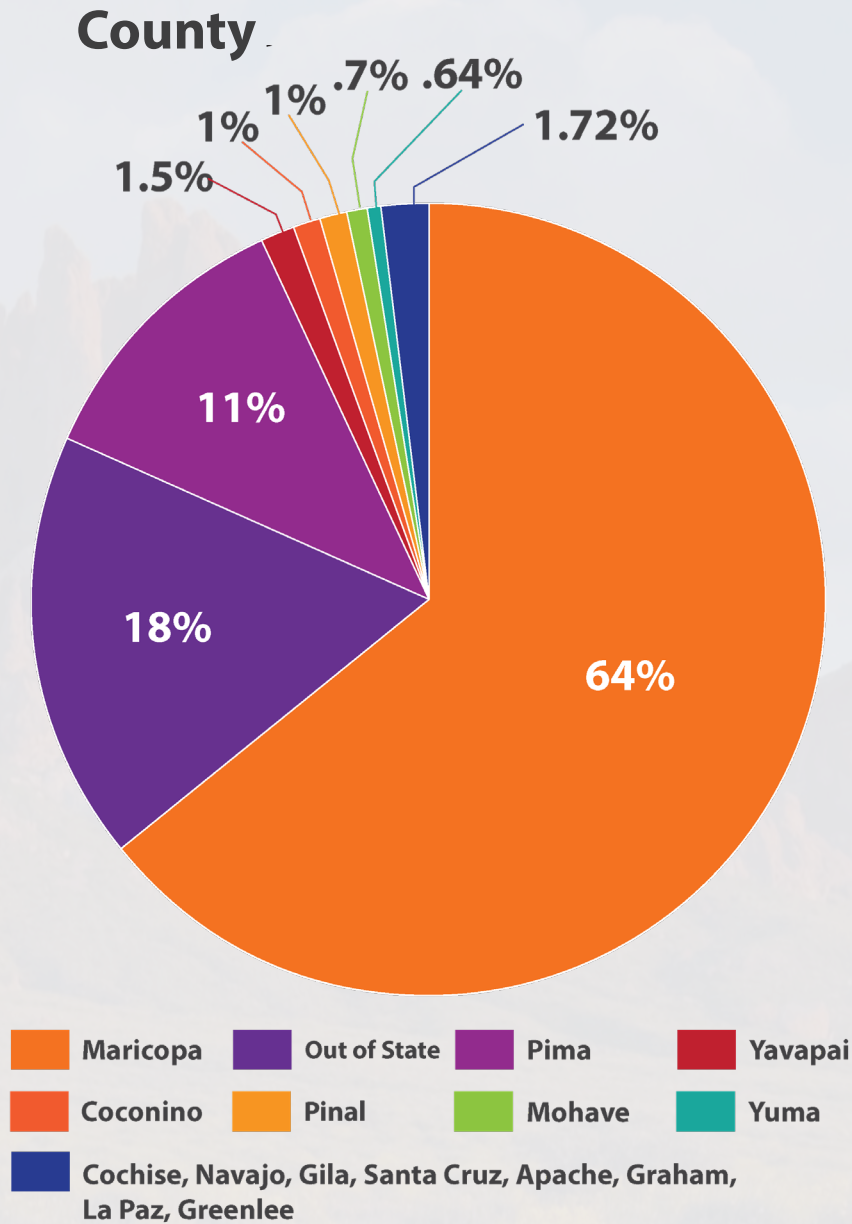

Sexual Orientation & Disability

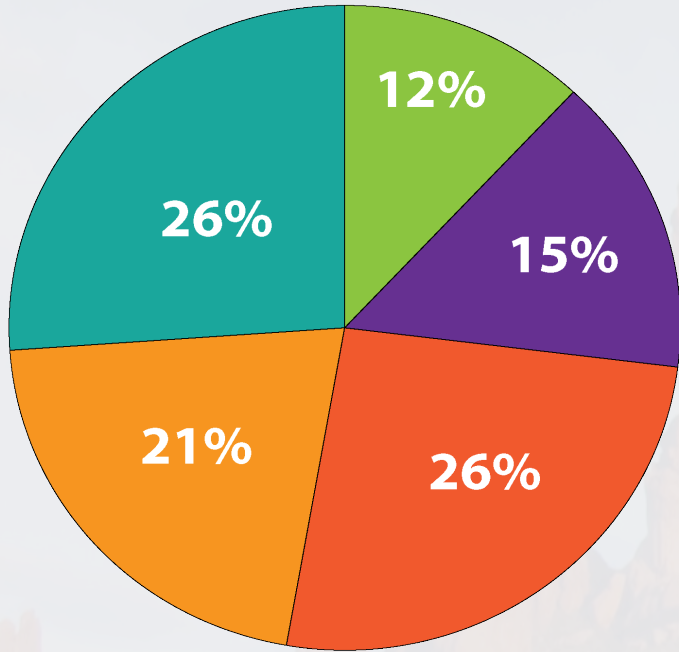
State Bar of Arizona members can voluntarily disclose their LGBTQ and disability status. At this time, only 20 lawyers have disclosed their LGBTQ status, and only 21 have disclosed a disability. Because this response is such a minute portion of the membership it is impossible to draw any conclusions about representation of our member population. No reliable national statistics are available on the total number of lawyers who identify as LGBTQ or have disabilities in the legal profession overall.

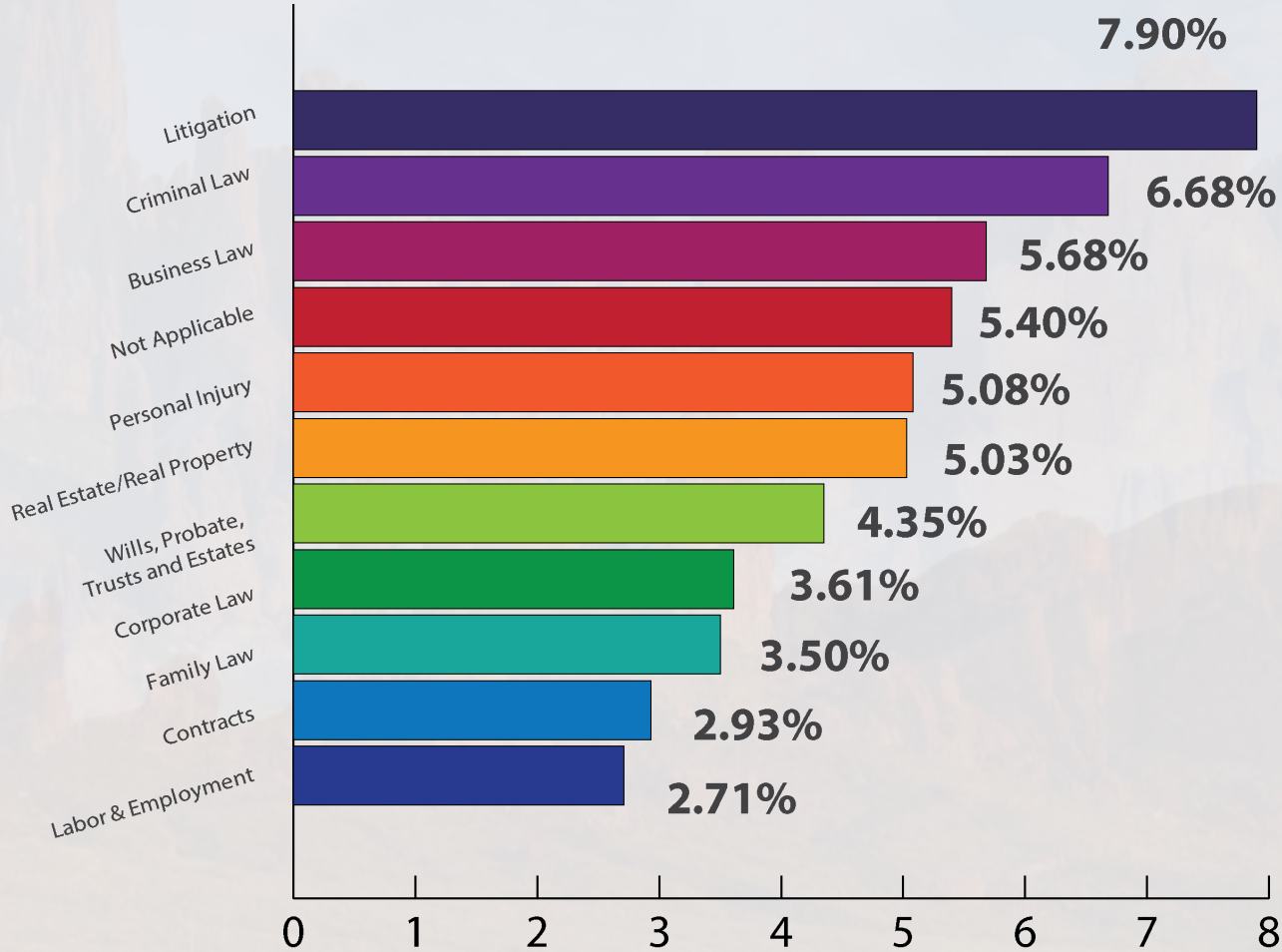
