## <u>Call to Order</u> – Ted Schmidt

President Schmidt called the meeting to order at 12:16 p.m. in the Marina Room at the Hassayampa Inn in Prescott.

President Schmidt made a Call to the Public and hearing nothing, moved on to the next agenda item.

### **President's Report** – Ted Schmidt

- Attended:

- Met with the Governor, thanks to Dave Byers
- Will be establishing a Task Force to promote Rule of Law
  - ➤ Shared with new Chief Justice and she volunteered to be on the Task Force

- CEO Joel England, President-elect Sam Saks and President Ted Schmidt will travel to Chicago next week to attend the National Conference of Bar Presidents Meeting
- President Schmidt has begun working on plans for the 2025 Convention
  - Lori Zucco, President of the Cochise County Bar will, be a convention co-chair
- President Schmidt reminded the Board about the Holiday Party with the Tucson Bar on December 6<sup>th</sup> at Hacienda del Sol
- Recommends having orientation with new people on committees

## **CEO/ED's Report** – Joel England

Mr. England thanked all for attending the Retreat.

He then gave a presentation regarding the 2<sup>nd</sup> Quarterly Highlights:

- Strategic Priority 2: SBA works to improve and sustain the justice system so it if fair, just and accessible to all
  - > Access to Justice Events
    - o Glendale Resource Fair
    - o Partnership created with Arizona Women's Foundation
      - 3 Let ABC 15 Know events landlord/tenant, estate planning, consumer law and Law Day Legal Clinic...helped 366 people
      - ABA Day in D.C. supported Legal Services Corp Funding (engaged 8 members of Congress)
- New Access to Justice Committee formed
- Client Protection Fund paid 13K in satisfying 5 claims
- Conservatorship Program returned \$13.8K in client funds, inventoried 171 client files, returned 29
- Fee Arbitration Program resolved 23 matters
- Foundation/LSO support
  - Facilitating State-wide Legal Needs Survey
  - ➤ 1<sup>st</sup> Joint Bar/Foundation report
- ChatBot Tool soft launched in May to engage website visitors average of 20 conversations/day so far
- **Public Service Center** assisted 214 callers
- **Resource Center** assisted 3,185 callers from the public

CEO England requested feedback regarding the report and stated that the goal is to give this information to the Board.

## Finance and Audit Committee - Jessica Iennarella

- Q2 2024 Financial Statements
  - As of June 30, 2024, operational surplus of \$1,175K relative to a budgeted surplus of \$242K. Investments \$628K surplus, resulting in a positive change in net assets of \$1,804K.
  - ➤ In August have department meetings related to the 2025 budget process and will dig into variances from budget in detail.
  - Revenue is current \$238K higher than budget, but majority of variance likely timing due to CLE by the Sea registration.
  - Expenses are currently \$695K less than budget, with the variances spread among a variety of line items and departments.

CFO Jessical Iennarella indicated that we will hear more about this at the September Board Meeting, after she's done an August deep dive.

- Fiscal Responsibility
  - Financial Policies and Processes Manual
    - Manual purpose: Policies & procedures to fulfill fiduciary responsibility to Members and the Supreme Court of Arizona.
    - o Manage, invest and safeguard financial resources.
  - ➤ Document is maintained by CFO and any revisions are approved by Senior Leadership, Finance & Audit Committee and Board of Governors.
    - o Last comprehensive revision 3/25/2022
    - o Next will be in 2025
  - ➤ Appendices to be most familiar with
    - o Appendix A: Reserve Policies
      - At the end of each year, surplus is allocated between reserve accounts
      - Appendix A dictates purpose and allowed use of reserve accounts
      - Capital Reserve Goal is to have sufficient funds for five-year capital budget (no line of credit)
      - Annual Fees Reserve Reduce and/or delay the need to increase annual fees in a future year(s)
      - Opportunity Reserve Special Projects; Innovation; Mission Driven Expenses;
        Unexpected Emergency; Discipline Costs as Ordered by PDJ
    - o Appendix D: Finance-related Responsibilities
      - Board of Governors (Page 36) Approve budget & policies
      - Finance & Audit Committee Monitor budget & compliance
      - CEO Implement budget & assure compliance
      - CFO manages financial operations & establishes controls
      - Staff Members Safeguard & apply resources

### **Convention Report** - Roberta Tepper

Ms. Tepper advised that we had a good Convention.

- Reviews from seminars positive; good response to plenary session, etc.
- We did not have attendance budgeted for, or as many 3-day attendees
  - ➤ 800 attended education seminars

- Board Advisor Benjamin Taylor suggested that a big name will draw more people
- We need to figure out how to have attendees stay after lunch, as we had about 200 people who only attended events including the Friday lunch
- Reminder 2025 convention June 23-25, M-W

### **CLE by the Sea Report** – Roberta Tepper

- This was the first year this event was not held at the Hotel Coronado
  - > It was held at Marriott on the Bay side of the island
- Most people were very happy
- Good attendance (200) with 4 rather than 5 tracks
- CLE sent out a survey regarding the Marriott (which is cheaper) vs. the Hotel del Coronado
- Revenue positive
