President Sanchez called the meeting to order at 8:35 am.

President Sanchez made a Call to the Public and hearing nothing, moved on to the next item on the agenda.

#### President's Report – Jessica Sanchez

- Convention

- Attended:
  - Los Abogados event Feb. 24 Jessica Sanchez featured regarding first Latina State Bar President; family members spoke.
  - Latinas Mentoring Program lunch.
  - State Bar's Bar Leadership Institute Reception March 23. Benjamin Taylor also attended.
  - WSBC March 29-April 1 Joel England also attended. Comforting to learn Arizona is not the only Bar facing challenges and that the SBA is actually ahead in terms of innovation in many areas. Artificial Intelligence figured prominently in programming.

### **CEO's Report** – Joel England

- Events:
  - Same events President Sanchez attended.
  - Met with Maricopa County Attorney Rachel Mitchell to establish relationship.
  - ABA's Bar Leadership Institute with President-Elect Taylor; former State Bar CEO John Phelps was a presenter.
  - ▶ Held president's orientation with Mr. Taylor.
    - He'll be making Bar committee appointments and Board assignments before the Convention; committees application deadline was extended.
- Staff performance evaluations and merit increase process completed.
- Election
  - Results from vendor in materials; topic later on the agenda

Uniform Law Commission - Commissioners Barbara Atwood, Tim Berg, Hon. Sam Thumma

- Provided an update on recent uniform laws that are being enacted around the country including two in the family law arena the Uniform Cohabitants' Economic Remedies Act (2021) and the Uniform Unregulated Child Custody Transfer Act (2021).
- Invited suggestions for laws for the ULC's consideration; fielded questions regarding budget and funding and indicated that each state pays dues based on size; commissioners are not salaried
- Have established rapport with commissioners from Colorado, New Mexico and Utah for sharing information and ideas
- ULC established in 1892; one president from Arizona since; Mr. Berg will be the 2<sup>nd</sup> and serve a two-year term

### Arizona Commission on Access to Justice – Hon. Sam Thumma

- Judge Thumma is current chair of the Commission established by the Arizona Supreme Court in 2014
- Referenced 2022 Annual Report and Plan for Excellence in Board's materials
- One change can make a difference in how legal consumers access courts
  - Rate of tenants failing to appear in landlord/tenant cases dropped from 40% in 2019 when one had to appear in court, to less than 25% in 2020 during the pandemic when virtual options were approved by the Court

- Four corner states face same challenges with regard to consumer legal access
  - Participated in successful Utah Summit takeaway: state agencies should replicate what each other does
- June 2023 issue of Arizona Attorney Magazine article on how we treat litigants
- Working to have 2025 AZ Town Hall's topic on access to civil justice; last similar one was in the 1980's

**ABA House of Delegates' (HOD) Midyear Meeting Report** – Diandra Benally, George Chen, Lynda Shely

- Thanked CEO Joel England, General Counsel Lisa Panahi and Director of Board Operations Carrie Sherman for arranging pre-HOD meetings with the Bar's five Delegates in order to provide an analysis of the Resolutions and whether any are <u>Keller</u> violative and thus prohibits the Delegates from voting on said matters. At the Midyear Meeting about 50% of the Resolutions were not <u>Keller</u> appropriate.
- Referenced the House of Delegates' Midyear Meeting recap in the materials and called out some matters including:
  - Resolution 400 (adopted) adopt a code of judicial ethics binding on justices of the Supreme Court of the United States
  - Resolution 300 (not adopted but expected back with amendments at the August Annual Meeting) – making amendments dated February 2023 to Standards 501 and 503 of the ABA Standards and Rules of Procedure for Approval of Law Schools. Former Chief Justice Scott Bales and Former ABA President Patricia Refo spoke in favor of the Resolution.
- Recognized the Board's own Governor and ABA Delegate Diandra Benally who received the Spirit of Excellence Award, one of the top five ABA awards that are presented.

### Finance and Audit Committee - Kelsi Lane and Kathy Gerhart

Year-end December 31, 2022 Financial Statements - 2022 SBA Final Operating Results (Internal)

- Net operational surplus of \$1,618K relative to a budgeted surplus of \$388K
- Surplus is a result of revenues overachieving budget by \$683K, and expenses coming under budget by \$547K.
- A couple of highlights are:
  - Higher than anticipated CLE revenue, advertising sales and rental income
  - Lower than anticipated banking & credit card fees, as well as personnel cost savings driven by higher-than-normal vacancies.
- No further adjustments anticipated preparing for the financial statement audit for which fieldwork is scheduled in May.
